This is a deceitful practice by Russian Refineries to suck in Buyers then issue Ghost Documents not listing them in the procedures in hopes that the Buyer be afraid of being Blacklisted if her/she does not comply and that is why we **Atlantic Petroleum Company** are terminating these sales and listing this deceit on our website to show other Buyers what to expect from LUKOIL one of the 5 esteem largest refineries in Russia. See the attached Ghost ATV quietly sent to us with instructions and nowhere even implied or suggested in the procedure as you can see, **See Attached**. Here are the procedures;

- 1. Buyer issue ICPO with his passport to the seller.
- 2. Seller Issue NCNDA/IMFPA and SPA for 13 months with R&E to review and sign.
- 3. Seller issues Commercial Invoice (CI) for the available quantity in the Seller storage tank, Buyer signs and returns the CI to Seller with their signed Tank Storage Agreement (TSA) for Seller approval. GHOST ATV WAS SENT TO US HERE AND HAS STOPPED THE SALE
- 4. Seller issues the partial PPOP documents as below;
- a. Commitment to supply
- c. Authorization to Verify (ATV)
- e. Unconditional DTA
- g. Tank Storage Receipt (TSR)
- i. Injection Report

- b. Product certificate of origin
- d. Tank to tank injection agreement (TTTIA)
